



VICTORIA GOLF CLUB MEMBERSHIP CATEGORIES



VOTING CATEGORIES

ACTIVE 29+

DUES: \$306-\$422/month

Adult men and women. Active Members have full privileges of the Club and full playing privileges as prescribed by the Board. (Active members between 29-34 pay monthly dues of \$306)

ACTIVE ASSOCIATE

DUES: \$211/month

Full privileges of the Club and restricted to 20 rounds per year (12 included and option to purchase an additional 8. This category must be joined before the age of 40 or if a spouse is in the Active category.

NON-PLAYING

DUES: \$134/month

Members who are unable to play full rounds of golf for health related reasons. The Member shall retain full Clubhouse privileges but shall have no playing privileges.

LIFE

NO DUES

A Life Member shall have all the privileges of an Active Member without payment of any subscription. The election of a Life Member is made by the Board. It is considered the highest honour as a member.

NON- VOTING CATEGORIES

NON-RESIDENT

DUES: \$112/month

Member whose primary residence is either north of Ladysmith or off Vancouver Island for 6 months or more per year. This category includes six rounds of golf per year.

SOCIAL

DUES: \$115/month

Member who has full privileges of the Clubhouse but is a non-golfing category.

NON-ACTIVE

DUES: \$115/month

Former Active Member who has full privileges of the Clubhouse but no longer actively plays golf.

ACTIVE WAITLIST

DUES: \$115/month

Member who has applied for Active Membership and who has paid a down payment on his or her Entrance Fee in the amount of 25% of the current fee. This member has been vetted by a committee member and restricted to golf privileges as prescribed by the Board.

SENIOR

DUES: \$316/month

Active Member having reached the age of 75, is entitled to transfer to Senior.

SERVICE

DUES: \$422/month

Commissioned Officer of the Canadian Forces having been elected by the Board shall remain in such categories at the pleasure of the Board (No Entrance fee and pays the current Active Dues)

INTERMEDIATE

DUES: \$112-\$167/month

Members aged 19 to 28. From 19-23 the monthly dues are \$112/month with limited golf privileges. Monthly dues for Intermediates age 24-28 are \$150/month with no playing restrictions.

**INTERMEDIATE
NON-RES**

DUES:\$803/year

Non-Resident' status if they qualify with Non-Resident qualifications as stated.

JUNIOR

DUES:\$57/month

Junior category quota is set by the Board. Junior Eagles (between the age of 7-11) will pay Junior dues with limited golf access.

LEAVE OF ABSENCE

DUES:\$56/month

Requires Board approval and has no golf privileges.

OTHER CATEGORIES**SUSPENDED**

No Dues

Set by the Board of Directors for indebtedness or conduct unbecoming of a member of the club

HONORARY

No Dues

Having been elected by the Board and shall remain in such categories at the pleasure of the Board.

DORMANT

No Dues

Members between the ages of 19-39 desiring to retain their Membership but to withdraw from Club activities for a period of time. (No further entrance fee payments required until membership is reactivated. Prior payments are accumulated however the rate of entrance will be 50% of the then current entrance fee).

DORMANT 2

No Dues

Members between the ages of 19-39 desiring to retain their Membership but to withdraw from Club activities for a period of time and continue to contribute towards their entrance fee payments. Their entrance fee is locked in at 50% rate of Active entrance.
